- FORMAT:**
- Four each, team pools of four (4).
 - Brackets will be re-evaluated two weeks prior to the tournament to ensure competitive play.
 - The 1st and 2nd place team in each pool will advance to one championship bracket while the 3rd and 4th place teams will advance to another championship bracket.
 - Teams are guaranteed four (4) matches
- TOURNAMENT RULES**
1. POOL PLAY: Teams will play two of three games 21 points, rally scoring – no cap. The third game will be played to 15.
 2. CHAMPIONSHIP ROUNDS: Teams will play best 2 out of 3 games to 25 points, rally scoring – no cap; game 3 will be played to 15. Once you lose, you are done for the day.
 3. Warm up between matches is three minutes per team.
 4. Two timeouts per game.
 5. There is to be no warm up in the lobby.
- POOL STANDING CRITERIA:**
1. Pool Record.
 2. Head to Head Competition.
 3. Overall Game Winning Percentage (Games Won / Total Games)
 4. Fewest defensive points in pool play.
 5. Most offensive points in pool play.
 6. Coin Flip.
- NOTE: Once one tie is broken in a multiple (3 or more) tie, you start over in the tie breaker procedures.

- WARM UP BALLS:** Teams are responsible for providing their own warm up balls.

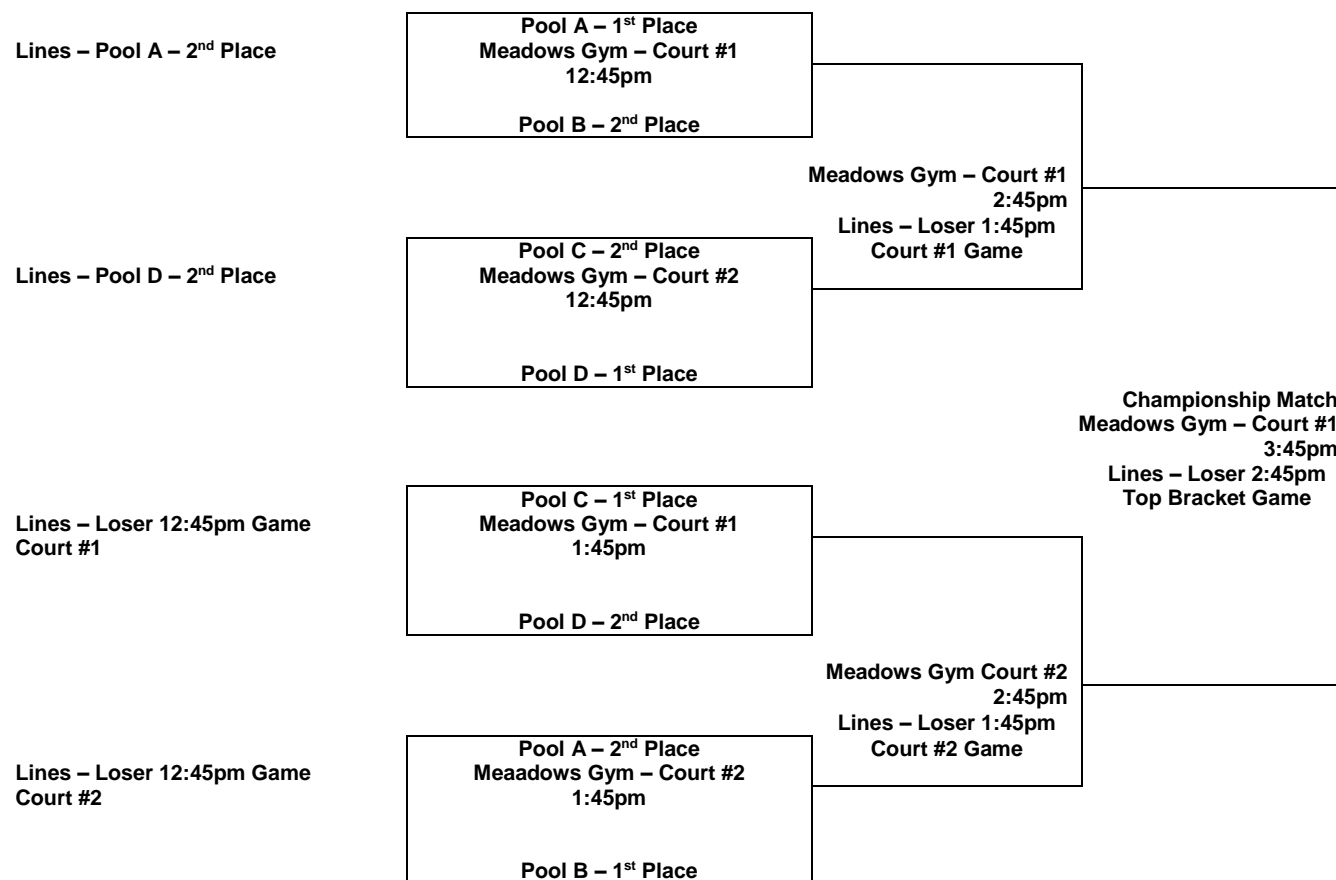

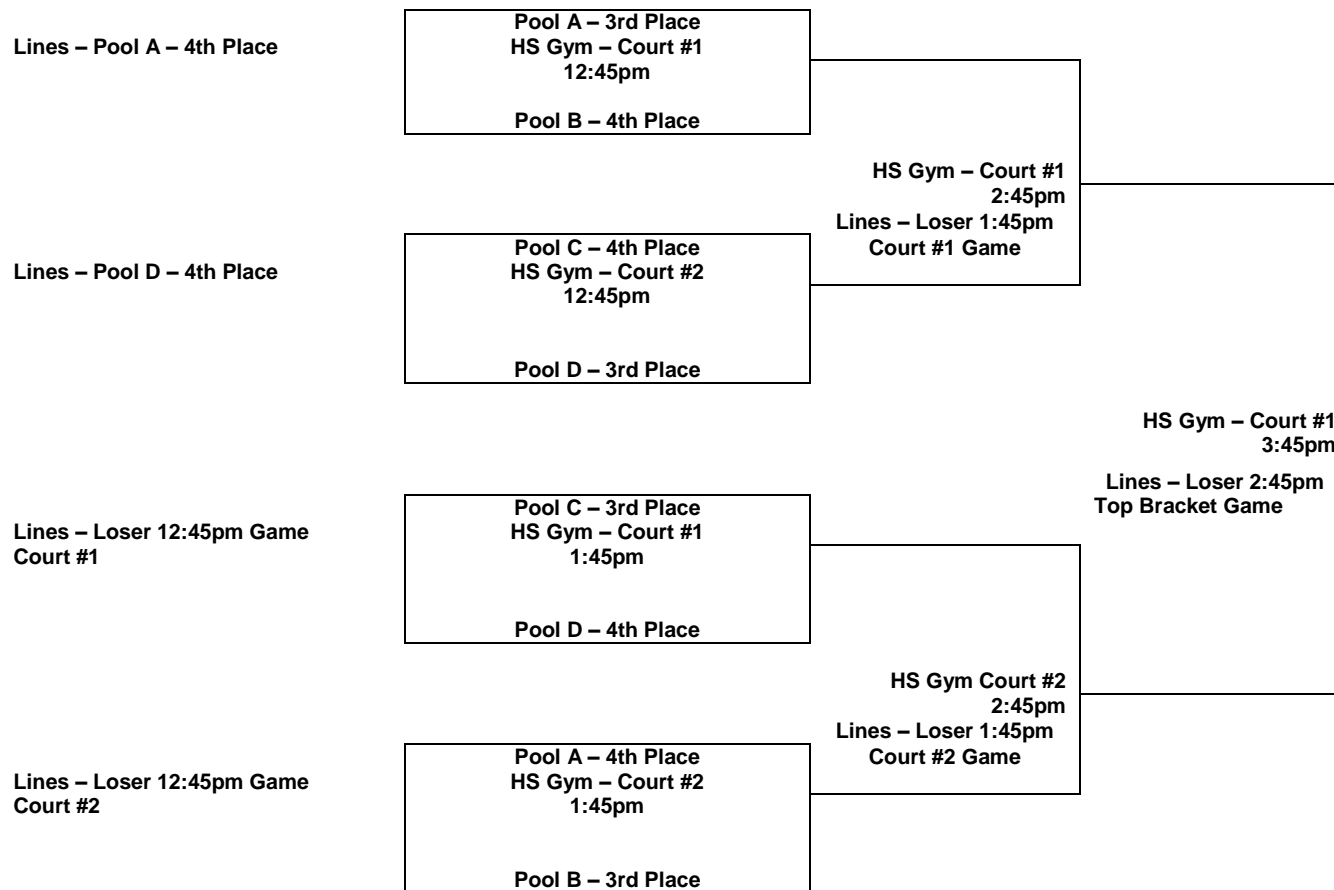
Championship Bracket
